<u>EarthCare request:</u> Via email, Jeff Johnson, EarthCare Ministry & Faith Alliance for Climate Solutions (FACS) representative, reported the EarthCare Ministry in partnership with the Unity of Fairfax Board of Trustees has annually contributed \$500.00 as a year-end contribution to FACS. On November 8, 2022, the EarthCare Ministry Team approved a \$250.00 contribution from its Sacred Grounds Fund; and requested a matching \$250.00 contribution from the Board of Trustees.
