Executive Session

An Executive Session was called to order at 7:05 pm EST and ended at 7:18 pm EST.

Minister's Report: Attached as Appendix 1. Rev. Russ reviewed his monthly report. He also made a motion regarding accepting new members who will be presented for membership (see Motion 2 below). Any and all questions were answered.

Nominating Ministry Team: Bowman Kell and Sherrie Quander reviewed progress in efforts to move forward with two candidates who are in discernment about joining the 2025 Board. Kalahn Taylor-Clark will be assuming the role of Board representative for the Nominating Ministry Team during Sherrie Quander's recovery.

Old business:

Fun Fest Auction Update: Millicent Eubanks provided an overview of the Fall Fun Fest Auction team's progress to date. The Team, led by Rob Chavez and Rob Jacoby, is currently accepting donations. The Auction will commence on October 6th and conclude on October 27th.

Mildred Park Task Force: Bowman Kell reported the task force recommendations are underway and an update will be provided at the September Board meeting.

New business:

<u>Secular Policy Recommendations</u>. Ed Merritt shared the recommendations from the Finance Committee regarding grants from congregants' employers who offer matching grants to charitable organizations and

requires that such grants can only be used for "non-religious" charitable purposes. A draft policy that aligns with the intent of the grants was reviewed and will be re-submitted at the September Board meeting.

<u>Asset Transfer Motion</u>. Ed Merritt reviewed the structure of short-term cash investments included among Unity of Fairfax's assets. See motion 3 below.

<u>UWM Delegates</u>. Rev. Russ discussed UWM's upcoming virtual Annual Business Meeting. Unity of Fairfax can have four delegates at this meeting, in addition to Rev. Russ and Linda Powell, LUT. He encouraged Board members to consider attending and taking the required <u>voting delegate training</u>. This matter will be discussed further at the September Board meeting.

MOTIONS:

MOTION 1: Approval of July 30, 2024 Board of Trustees Meeting Minutes. The motion to accept the minutes was made by Bowman Kell and seconded by Kalahn Taylor-Clark. The motion was unanimously approved.

MOTION 2: Rev. Russell Heiland made the motion that Unity of Fairfax accept the following twelve (12) individuals as Voting Members (ceremony to be held on September 15): Sterling Wilde, Duane Bowers, Jack Tarr, Megan James, Sue Carillo, Soni Weiss, Guerline Osterval, Mary Histing, Cindy Vough, Floyd Perez, Patty Waschitzki, Cathi Stallings. Seconded by Ed Merritt. The motion was unanimously approved.

MOTION 3: Whereas the church currently holds a substantial amount of reserve funds in very low interest-bearing accounts, the Board directs the Director of Finance or other staff designated by the Minister to research options for obtaining higher rates of returns on these funds, taking into consideration as well issues such as:

- the future accessibility of the funds,
- that they are held in FDIC insured accounts, such as Certificates of Deposit, High-yield Savings and Money Market Accounts,
- along with any other considerations deemed relevant by church staff.

The Board further allows staff to present alternatives upon completion of its analysis for approval and authorization by the Treasurer. The motion was made by Ed Merritt and seconded by Millicent Eubanks. The motion was unanimously approved.

Midd Hunt's Vietnam presentation to the Sages on August 21 had a full house and was much appreciated by all. Tammy Nguyen provided additional support.

We distributed over 250 Unity bags at Oakton Day in the Park on August 25.

Unity of Fairfax officially enters into a relationship with a new non-profit Fairfax Secular Homeschool Collective (FSHC) whose Board President is Annie Tomastik, daughter of Nina Gibson and Tim Tomastik. FSHC will be in the building on Tuesdays and use a few rooms. This is an organization that brings together children who are homeschooled, and although this is not a big money-maker, it is a great way to introduce many families to Unity of Fairfax.

Prayer Chaplain installation will be in Sunday Service on September 8.

Homecoming/New Member Sunday is September 15. The church will provide expanded hospitality that day. New Voting Members will be installed. Daniel Nahmod will be our guest musician on September 15. He will do a concert that day as well.

Unity Awakening 2024 will run September 22 - November 3. The source material will be *In the Flow of Life* by Eric Butterworth. I am reprising this material from 2013. On Sunday, September 29, Revs. Johnson, Butler, and Karstetter will be joining me on the platform for the message. I expect to have 6 small groups, something I consider a win since we haven't had small groups in a few years.

Jan Garrett and JD Martin will be guest musicians on September 29.

The Celebration of Life Service for Rev. Jane will be on September 29 preceded by a luncheon. Church will most likely be set up cabaret-style that day. Concelebrants will be Rev. Donna Johnson, Rev. Sandra Butler, Rev. Ron Karstetter, Rev. Trish Hall, and me.
