## **Minister's Report**

**Motion 1:** I move that the Board authorize an ongoing tithe, until further review is requested, of \$250.00/month to Truthunity.net effective with January 2018 tithes to be paid in February. Unity

of Fairfax has made periodic tithes to Truthunity.net; however, owing the expansiveness and import of this web resource, I think it warrants ongoing support. Seconded and approved unanimously.

**Motion 2:** I move that the Board authorize expending \$10,000 for the new projector system. The current projector fund balance on hand is \$9,500 (as of 1/28/18). At the September 16 meeting, \$6,000 was authorized; however, since that time, the vendor selected has not been in contact with Unity of Fairfax in spite of repeated attempts to connect with him. We contacted the vendor who installed the livestream equipment, who provided us with 3 options ranging in price from \$8,600 to \$10,200. The team coordinating this project is Midd Hunt and Dave Wiley, with input from Cecil Davison, Mike Mulraney, Ron Wagner, Marianne Tagge and myself. Technical documentation appended to this report. Once approved, I will sign the appropriate documents and arrange for payment.
