- Sent to you under separate cover are the Unity of Fairfax and Pinnacle Safety plans. They will both be posted in all classrooms. These fulfill the intention of the Health and Safety Policy of Unity of Fairfax on which the Trustees will vote separately in this meeting.
- The new Social Justice Team is taking shape. The team has designated Jacqueline Smith as leader (Jacque is a former Trustee) and have determined their vision/mission statements as:

Vision: A committed community living our Unity Principles through engagement in social action

Mission: To inspire Unity of Fairfax to participate in activities promoting social justice, equality, and respect for All.

I am not requesting formal approval of the Team at this time. The Team would like to be on the agenda at the May community dialog meeting in order to assess community interest in justice issues; however, it may be prudent to have a separate community meeting for this purpose. Also, I'd like more detail about the Team's vision for specifics on proposed social justice activities. I will report back to the Board what I learn. *If a Trustee would like to be included in my meeting/conversation with Jacquie, please let me know.*

- Unity of Fairfax is engaging in 2 specific Season for Non-Violence activities this weekend: guided tour of the National Museum of the American Indian (2/24), and showing the moving "White Like Me." (2/25) The "Season" is a product of the Association of Global New Thought, in which Unity Worldwide Ministries and Unity World Headquarters at Unity Village are members.
- Unity of Fairfax has booked the following speaker events: James Hollis, PhD for June 16 and Rev. Edwene Gaines for August 12. Hollis is a Jungian analyst who lives in DC. His work is amazing. Visit his website for more information: jameshollis.net. Rev. Edwene is the Unity movement's foremost prosperity teacher. This is a NOT TO BE MISSED opportunity to participate in a life-changing experience!
