**MOTION 03/26/2020:** Approval of Pinnacle early lease termination: The Board approved unanimously to settle an early lease termination. BoT agreed to accept \$31,000 and forfeiture of the \$35,000 security deposit.

**MOTION 03/26/2020: Pinnacle Lease Termination agreement for review and approval.** The Board approved unanimously to settle in exchange for Pinnacle providing Unity of Fairfax \$31,000 and forfeiture of the \$35,000 security deposit for past due lease payments, retention of all furniture and fixtures, other codicils and execution of the agreement. BoT voted unanimously to terminate the lease with Pinnacle and all future payment requirements.

# **Information Items:**

On May 26 requested Comms Team assistance in crafting regular donor letters to mail to the congregation. My suggestion is these would be mailed roughly every six weeks through year end. Each would incorporate a special theme and be sensitive to those for whom this is a financially challenging time. Idea in discussion among the Comms Team.

The Reopening Task Team had its first meeting on May 23. Chaired by Ron Karstetter, the team also includes: Nancy Schneider, Teresa Accomando, Jacquie Smith, Dave Colburn, Maci Moser, Kathy O'Brien, Deidre Richardson, Ellie Hunt (joining on May 23). Guiding principles were shared on Sunday, May 24. Next meeting is on Saturday, May 30. The Team is taking a conservative approach. In a related note, I've conferred with several other NoVa faith communities. The Catholic parishes are following the guidance of the Arlington Diocese. The NoVa UMC churches are close to in-person activities until at least July 5. A smattering of other communities shared they plan to be closed at least through July, possibly August as well.

On June 7 during Sunday services we will honor our 5 graduating High School Seniors.

I'm endeavoring to connect with Scott Smith of Hunter Mill Montessori to discuss his plans/needs for the Mildred Park Center. I hope to have something to share at the meeting; as of this writing, I have not heard from him in a few weeks.

On May 26, I concluded the Tuesday Happy Hour. On Tuesday, June 16 I will be given a 7-week evening Zoom gathering focused on Dream Work and the Unity Movement.

On May 28, the Thursday Coffee Klatch will be concluded. On Thursday, June 18 Ron Karstetter will begin a morning Zoom class based on the book *The Art of Abundance* by Dennis Merritt Jones. Class will last 7 weeks.

Tony and I crafted a Fire Evacuation Plan for the Fairfax County Fire Department. This is a new requirement effective 2020. Sent to FCFD on May 27.

The migration from our old Quickbooks Online account to the new (and much less expensive) Quickbooks Online account was completed on Tuesday, May 26.

Jody Ruth lead an awesome webinar for UWM entitled "Shield the Vault" about financial controls and wisdom on May 26. This was supposed to be a workshop at the 2020 Unity Convention. She had 21 students. I participated as well. Her presentation was much appreciated by attendees, and I anticipate she will offer more such programs to UWM in the future.
